Committee Charge: This committee, which serves primarily as a liaison between the HHS faculty and the Dean, may convene to discuss any and all matters that affect the responsibilities, rights, and welfare of the college's faculty. The committee meets with the Dean at least once each semester to discuss topics of special concern to the faculty. Working in collaboration with the dean, the committee establishes a process for the regular review of deans and heads. In addition, the committee reviews the college's bylaws every five years.

I. Committee Activities Accomplished since October 2023:

The Faculty Affairs Committee met with Interim Dean Bowman and Senior Associate Dean Berndt in December 2023. This meeting focused on four broad talking points: updates on the HHS Dean Search, updates on pending and planned HHS faculty searches, discussion of possible improvements for research operations, and guidance on the future of DEI efforts across the College.

In recent years, the Faculty Affairs Committee has met with the HHS Dean once per semester. Interim Dean Bowman expressed an interest in more frequent meetings with the committee to continue to discuss College-level matters. We convened in March 2023, and this meeting focused on four broad talking points: discussion of the agenda and format of the Spring HHS Spring Faculty Meeting, updates on the HHS Leadership Advisory Committee and Dean Search, hearing the oral history of the founding and mission of HHS, and discussion of the broader implications of Indiana Bill SB202 for Purdue.

Summaries of the discussions from both meetings were distributed to Committee members, to be shared with their Units. The next meeting is planned for May 2024.

Bylaws Review: A set of updates to the HHS bylaws were reviewed by the Faculty Affairs Committee, Senior Associate Dean Berndt, and Interim Dean Bowman. The proposed updates were approved by the Faculty Affairs Committee. Changes were disseminated to the faculty for a final vote at the Spring HHS Faculty Meeting.

Graduate School Updates

- As of the writing of this report, there is still no concrete information about changes to the Graduate School structure. It is likely that changes will be minimal as many of the core functions of the Graduate School will need to remain centralized. However, certain programs are likely to be eliminated. A report was submitted to the University Senate in February and a search for a Vice Provost to lead Graduate programs and Postdoctoral studies is expected soon
- University just decided on a new graduate student record database - Salesforce.
- Another graduate student minimum stipend increase is being evaluated. No firm information but a new rate may take effect in summer 2024. PGSG is requesting a \$32K FY amount. FY24-25 minimum remains at \$28k.

Other activities under the responsibility of the Associate Dean of Graduate Programs and Online Education

- Online Learning Committee: Established to help promote and enhance HHS efforts in online, hybrid, and professional learning. The committee provides advice to the Dean and unit heads on the administration of the HHS online,

hybrid, and professional academic programs. The committee also provides guidance for creating or revising online, hybrid, and professional programs, fosters and identifies professional development opportunities and resources for faculty and staff engaged in online, hybrid, and professional learning, and collaborates with internal and external Purdue partners to offer HHS programming to diverse audiences.

Committee Charge: This committee focuses on such matters as the improvement of undergraduate instruction, honors programs, core requirements, graduation requirements, curriculum standards, general academic organization, interdepartmental undergraduate programs, and policy issues related to the college's undergraduate programs. Also, the committee evaluates proposals for creating or revising undergraduate courses and programs.

I. **Committee Activities Accomplished since October 2023:**

During its meeting on November 16, 2023, the committee heard a presentation on The Data Mine by Stacey Dunderman, Lead Program Administration Specialist; and Nicholas Rosenorn, Corporate Partners Technical Specialist for The Data Mine.

The committee approved the creation of a new concentration in Radiation Health and Safety for the Radiological Health Sciences major of the School of Health Sciences.

During its meeting on January 25, 2024, the committee approved a proposal to suspend the Accelerated Nursing program, effective in Fall 2025. The committee also:

- Approved a new, optional Sport Management concentration for the Kinesiology major of the Department of Health and Kinesiology,
- Discussed information that is required or recommended for a Purdue University course syllabus in connection with proposals for new courses.

During its meeting on February 8, 2024, the committee:

- Approved new courses and changes in degree requirements for the Department of Human Development and Family Science major in Early Childhood Education and Exceptional Needs,
- Approved changes in degree requirements for the School of Hospitality and Tourism Management major in Financial Counseling and Planning,
- Approved changes in degree requirements for the Nursing major of the School of Nursing and for the dietetics majors of the Department of Nutrition Science,

- The committee also discussed procedures for the approval of changes in courses that are also taught at Purdue's regional campuses.

During its meeting on February 29, 2024, the committee:

- Approved changes in degree requirements for the Family and Consumer Sciences Education major of the Department of Human Development and Family Science,
- Approved ten (10) new courses in Hospitality and Tourism Management whose creation was proposed as part of a substantial revision of the degree requirements for the major of the same name in the school of the same name,
- Approved the changes in the degree requirements for the Hospitality and Tourism Management major that were tied to the creation of the new courses.

During its meeting on March 28, 2024, the committee:

- Approved revisions in five HTM courses that were another part of the curricular revision undertaken by HTM faculty this year,
- Approved the creation of a new course in Speech, Language, and Hearing Sciences on Pediatric Audiology,
- Approved some changes in degree requirements for the Speech, Language, and Hearing Sciences major in the department with the same name that will not be effective until Fall 2025 because the deadline for updates to the University catalog for the 2024-25 academic year had already passed.
